The undersigned is directed to refer to the subject cited above and to say that the 13 tariff lines (between 4104 to 4115) under Chapter 41 {Raw Hides and Skin (Other than Furskins) and Leather} of Indian Import Policy, 2017 have already been removed from purview of Animal Quarantine and Certifications Services (AQCS) by a Notification S.O. 5758 (E), dated 16th November, 2018 and circulated also by this Department's O.M. dated 7th January, 2019 (copy enclosed).

2. Now, vide Notification S.O. 4953 (E), dated 2nd December, 2021 (copy enclosed) of this Ministry, the following 17 tariff lines (between 4104 to 4115) under Chapter 41 {Raw Hides and Skin (Other than Furskins) and Leather} of Indian Import Policy, 2017 have been removed from purview of Animal Quarantine and Certifications Services (AQCS) with the condition that the authorized officer of manufacturer in exporting country gives a declaration on invoice along with each consignment stating that 'the product has undergone the irreversible process of tanning'.":

- 3. Customs is requested to consider release of consignments under above tariff lines itself based upon declaration from manufacturer in exporting country as stated in para 2 above.
- 4. In the absence of above stated declaration, Customs may consider to draw the samples for doing applicable testing in consultation with the concerned Regional Officer / Quarantine Officer, Animal Quarantine and Certifications Services at the cost of importer.
- 5. Considering the "Ease of Doing Business", the above system of clearance may be brought into operation completely w.e.f. 1 February, 2022 (60 days migration time after issuance of Notification S.O. 4953 (E), dated 2nd December, 2021) i.e. existing system of post import clearance by AQCS considering veterinary health certificate from exporting country with consignments and revised new system of post import clearance by Customs itself based upon declaration from manufacturer in exporting country as stated in para 3 above.
- 6. This issues with the approval of the competent authority.

S.O. 4953(E).—In exercise of the powers conferred by clause (d) of section 2 and section 3A of the Livestock Importation Act, 1898 (9 of 1898), the Central Government hereby makes the following further amendments in the notification of the Government of India in the Ministry of Agriculture, Department of Animal Husbandry, Dairying and Fisheries number S.O. 2666, dated the 16th October, 2014, published in the Gazette of India, Extraordinary, part-II, Section 3, Sub-section (ii), dated the 17th October, 2014, namely:-

In the said notification, in the Schedule, in paragraph (3), in sub-paragraph (viii), after the proviso, the following proviso shall be inserted, namely:—

S.O. 5758(E).—In exercise of the powers conferred by clause (d) of section 2 and section 3A of the Livestock Importation Act, 1898 (9 of 1898), the Central Government hereby makes the following further amendments in the notification of the Government of India in the Ministry of Agriculture and Farmers Welfare, Department of Animal Husbandry Dairying and Fisheries, published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (ii), *vide* S.0. 2666(E), dated the 17th October, 2014, namely:—

In the said notification,—

- (1) In paragraph (1), for sub-paragraph (xvii), the following sub-paragraph shall be substituted, namely:—
 - "(xvii) Medicaments (bovine albumin and drug of animal origin except vaccines and veterinary biological under the Drugs and Cosmetics Act, 1940) and diagnostics (containing blood or serum fractions for in vitro application)";
 - (2) In the Schedule,-
 - (i) in paragraph (3), in sub-paragraph (viii), the following proviso shall be inserted, namely:—
 - "Provided that for the livestock products listed at serial numbers (xix), (xx) and (xxi) of paragraph 1, except other of whole hides and skins, including sides of leather further prepared after tanning or crusting, parchment-dressed leather, of bovine (including buffalo) or equine animals or of other animals, without wool or hair on, whether or not split, other than leather of chamosis (including combination chamois) leather, no objection certificate of the concerned Quarantine Officer will not be required";
 - (ii) In paragraph (4), after the second proviso, the following proviso shall be inserted, namely:—
 - "Provided also that livestock products listed at serial numbers (i) to (xiv) of paragraph 1 shall be allowed to be imported into India through airport or land port, as the case may be, located at Raxaul

(Bihar), Jogbani (Bihar) and Atari (Punjab) under the jurisdiction of Animal Quarantine and Certification Stations in Kolkata and New Delhi, respectively:

Provided also that livestock products listed at serial numbers (viii) to (xxx) of paragraph 1 shall be allowed to be imported into India through the airport or land port, as the case may be, located at Fulbari (West Bengal) under the jurisdiction of Animal Quarantine and Certification Station in Kolkata:

Provided also that livestock products listed at serial numbers (i) to (xxx) of paragraph 1 shall be allowed to be imported into India through the airport or land port, as the case may be, located at Moreh (Manipur) under the jurisdiction of Animal Quarantine and Certification Stations in Kolkata:

Provided also that the import of aquatic products, eggs and seeds of all aquatic animals including fish, crustaceans, molluscs, the import shall also be allowed through the airport or land port, as the case may be, located at Moreh (Manipur) under the jurisdiction of Animal Quarantine and Certification Stations in Kolkata.".
